The JSPM University Act was issued on 6th January 2023 and subsequent to that, the notification declaring the formation of JSPM University, Pune was issued vide letter no. SFU 2022 /C.R. 26 /Uni.4 dated 16th January 2023. Thereafter the JSPM University, Pune was declared operational by the Department of Higher & Technical Education, Government of Maharashtra vide its letter no. SFU 2022 /C.R. 26 /Uni.4 dated 28th February 2023.

Furthermore, the JSPM university has obtained the 2(f) status from UGC vide letter No. F. No. 8-10/2023 (CPP-I/PU) Dated 16th May 2023 and the name of the JSPM University is enlisted on the UGC website at serial no. 450.

At the outset, Prof. B. B. Ahuja, Hon'ble Vice Chancellor extended a warm welcome to all the members present and having satisfied himself of the quorum, asked Mr. Vishal Choudhary, Registrar to present the agenda, item by item.

Prof. B. B. Ahuja welcomed the Hon'ble Members on the Academic Council of JSPM University Pune.

1.2 To inform the Hon'ble Members of the Academic Council about the formation of the JSPM University Pune; Act 2022 (Maharashtra Act IV of 2023) and subsequent notifications issued by Govt. of Maharashtra and University Grants Commission.

Prof. B. B. Ahuja, Hon'ble Vice-Chancellor informed the Hon'ble Members of the Academic Council about the formation of the JSPM University Pune; Act 2022 (Maharashtra Act IV of 2023) and subsequent notifications issued by Govt. of Maharashtra and University Grants Commission for consideration. He also informed the Hon'ble Member that Academic Sessions for A. Y. 2023-2024 will begin from 17th of August 2023.

1.3 To consider the University Organogram, establish Faculties, Schools, Departments and Centres of the University.

Prof. B. B. Ahuja, Hon'ble Vice-Chancellor introduced the Hon'ble Members of the Academic Council about the University Organogram, establishment of 5 Faculties, Schools, Departments and Centres of the JSPM University and also suggested to start School of Lifelong learning and Distance Learning in the University Campus. He also informed Mr. Mangesh Kulkarni and Hon'ble members that budget of Rs 1,00,00,000 (Rs. One Crore) is sanctioned for research and fellowship for Ph.D. Scholars by the Management. Dr. R. V. Kulkarni inquired about seats available Ph. D. Program admissions to which Prof. B. B. Ahuja informed members that the Ph. D. admissions will be limited to the intake as per number of eligible Ph. D. guides.

Prof. B. B. Ahuja informed members that JSPM University had conducted its first Research Program Entrance Test (JSPM RPET) on Sunday 16th July 2023 in online and proctored mode in accordance with UGC Regulations. Maharashtra Knowledge Corporation Limited (MKCL), an autonomous body of the Government of Maharashtra was engaged for this proctored research entrance test. He briefed that in the first Test 550 candidates took the test of which 444 candidates cleared the 1st RPET. He further mentioned that as there were many requests from prospective candidates wanted to pursue Ph. D. at the JSPM University, in the next Research Program Entrance test is scheduled on Sunday 6th August 2023 also in online and proctored mode. Subsequent to the two tests, those candidates who qualify with 50% aggregate marks in paper I and Paper II will be shortlisted for the interviews. However, selection of Ph. D. Candidates will be restricted to vacant seats available with the respective Ph. D. supervisors.
