The JSPM University Act was issued on 6<sup>th</sup> January 2023 and subsequent to that, the notification declaring the formation of JSPM University, Pune was issued vide letter no. SFU 2022 /C.R. 26 /Uni.4 dated 16<sup>th</sup> January 2023.Thereafter the JSPM University, Pune was declared operational by the Department of Higher & Technical Education, Government of Maharashtravide its letter no.SFU 2022 /C.R. 26 /Uni.4 dated 28<sup>th</sup> February 2023.

Furthermore, the JSPM university has obtained the 2(f) status from UGC vide letter No. F.No. 8-10/2023 (CPP-I/PU) Dated 16<sup>th</sup> May 2023 and the name of the JSPM University is enlisted on the UGC website at serial no. 450.

The Governing Body is requested to consider and note.

#### Agenda-1.3: To consider the University organogram, establish Faculties, Schools, Departments and Centre'sof the University.

The University has proposed following 5 Faculties keeping in view the new National Educational Policy, which demands multidisciplinary and holistic education with multi-entry and exit options.

- 1. Faculty of Science & Technology
- 2. Faculty of Health Sciences
- 3. Faculty of Business and Commerce
- 4. Faculty of Education and Humanities
- 5. Faculty of Interdisciplinary Studies

Under these Faculties, various Schools are proposed and under Schools with its corresponding Departments. The structure proposed is more decentralised with more authorities and powers to the Schools.

The details of Faculties, Schools, Departments and Centre's of the University are attached herewith as *Annexure-3* 

The Governing Body is requested to consider and decide.

## Agenda-1.4: To consider First Statutes and First Ordinances for approval by the State Government.

The status of the development of first statutes and first ordinances will be presented in the meeting and the governing body is requested to advise on the same.On receiving approval from the Governing Body,the same will be forwarded to the Government for sanction. The Copy of First Statutes and First Ordinances are attached herewith as Annexure-4

The Governing Body is requested to consider and decide.

Agenda-1.5: To consider nomination of two members of the Governing Body of the JSPM University Pune on the Board of Management of the JSPM University Pune.

As per the JSPM University Act, u/s 22 clause (1) (d)no. of the Governing Body members are to be nominated on the Board of Management. The Governing Body is requested to consider 3 members amongst them to be nominated on the Board of Management of JSPM University, Pune for a period of 3 years. List of Governing Body members is attached herewith –**Annexure 5** 

The Governing Body is requested to consider and decide.

Agenda-1.6: To make provisions for curricular, co-curricular, extracurricular activities for the students and employees.

The discussion on the agenda is to obtain the views of Hon. Members of Governing Body on the same. The details of curricular, cocurricular, extracurricular activities for the students and employees of various faculties are attached herewith-**Annexure 6** 

The Governing Body is requested to consider and advise.

Agenda-1.7: To consider creation of academic, technical, administrative, ministerial and other necessary posts.

As per the Institutional Development Plan (UGC), the Faculty to Student ratio mandated is in the range of 1:15 to 1.30 for UG programs and 1:10 to 1:15 for PG programs. With a view to maintain the quality of education in the JSPM University, it is proposed to the Governing Body to sanction the teaching posts for all the University's programmes with a 1:15 ratio.

It is proposed that, in view of the Digitalization, the non-teaching post including administrative, technical and supporting staff (ministerial staff and technical staff) be appointed in the ratio of 1:0.5, since housekeeping, peons and security services will be outsourced.

Further, it is proposed that, the housekeeping staff (dry & wet, inclusive of gardening), peonsand security be appointed on the contractual basis.

The requirement is part of the presentation as stated in the <u>Annexure-</u> 1

The Governing Body is requested to consider and approve.

Agenda-1.8: To fix fees and other charges, and to demand and receive such fees and other charges as may be prescribed from time to time.

In reference to, the JSPM University Pune Act the fee structure for various programs is to be submitted for approval to the State Government for their consideration. In this context, the internal committee was appointed under the chairmanship of Hon. Vice-Chancellor to finalize/suggest fee structure.

It is proposed that an internal fee committee to the University which will act as apre-review fee committee be appointed to appraise the proposed fee structure, which will then be submitted to the State Government as per the JSPM University Act.

The Governing Body is requested to consider and decide.

Prof. B. B. Ahuja, Vice Chancellor welcomed the Hon'ble President and Members on the Governing Body of JSPM University Pune and requested for their guidance and support to raise the academic standing of the JSPM University Pune and imbibe the best of academic practices.

<u>**R-1.1/2023</u>**: The Board **RESOLVED to Welcome** all the esteemed members on the Governing Board and express gratitude for their time and support to the University.</u>

# <u>Item 1.2:</u> To inform the Hon'ble Members of the Governing Body about the formation of the JSPM University Pune; Act 2022 (Maharashtra Act IV of 2023) and subsequent notifications issued by Govt. of Maharashtra and University Grants Commission.

Prof. B. B. Ahuja, Hon'ble Vice-Chancellor informed the Hon'ble Members of the Governing Body about the formation of the JSPM University Pune; Act 2022 (Maharashtra Act IV of 2023) and subsequent notifications issued by Govt. of Maharashtra and University Grants Commission for their information. Dr. S. B. Nimse citing the Maharashtra Public University Act suggested to incorporate the Section14/7 and Section 14/8 of the said Act in the University Statutes.

<u>**R-1.2/2023</u>**: The Board **NOTED** and **RESOLVED** to consider the JSPM University Act 2023 and to incorporate Section/Clause14-7/14-8 of the Maharashtra Public University Act in the JSPM University Statutes to empower Vice Chancellor thereto.</u>

## <u>Item 1.3:</u> To consider the University Organogram, establish Faculties, Schools, Departments and Centre's of the University.

Prof. B. B. Ahuja, Hon'ble Vice-Chancellor introduced the Hon'ble Members of the Governing Body about the University Organogram, establishment of 5 Faculties, Schools, Departments and Centre's of the JSPM University as appended in **APPENDIX-I**. Dr S. B. Nimse suggested to start Department of Lifelong Learning and Distance Learning in the University Campus.

<u>**R-1.3/2023</u></u>: The Board RESOLVED to APPROVE the JSPM University Organogram, establishment of 5 Faculties and to start Schools, Departments and Centre's at the JSPM University with effect from the ensuing academic year 2023-24. The Governing Board further <b>RESOLVED** to **APPROVE** Department of Lifelong Learning and Distance Learning under the School of Education.</u>

#### <u>Item 1.4:</u> To consider First Statutes and First Ordinances for approval by the State Government.

Prof. B. B. Ahuja, Hon'ble Vice-Chancellor presented before the Hon'ble Members of the Governing Body the status of the development of the First Statutes and First Ordinances of the JSPM University for approval by the Governing Body which would then be forwarded to the State Government for their final approval and subsequent notification. The members on deliberation on the subject matter decided to constitute a sub-committee under the Chairmanship of Dr. S. B. Nimse, former Vice Chancellor, Lucknow University, with Dr. B. P. Sabale, former Vice Chancellor of Yashwantrao Chavan Maharashtra Open University, Prof. R. K. Jain, Principal, Rajarshri Shahu College of Engineering, Dr. Ajit Thete and Prof. B. B. Ahuja to look into detail First Statutes and First Ordinances of the JSPM University and empowered the President to submit the same to the Government with modifications as suggested by the said sub-committee. **<u>R-1.4/2023</u>**: The Board **RESOLVED** to **APPOINT** a sub-committee for the consideration of the First Statutes and First Ordinances for approval by the State Government. The Governing Board further **RESOLVED** to **EMPOWER** the President of the JSPM University to accept the report of the sub-committee and submit the First Statutes and First Ordinances State Government for final approval and notification.

## <u>Item 1.5:</u> To consider nomination of two members of the Governing Body of the JSPM Univer\sity Pune on the Board of Management of JSPM University Pune.

Prof. B. B. Ahuja, Hon'ble Vice-Chancellor requested Dr. Ravi Joshi, Hon'ble President, JSPM University to nominate two members of Governing Body of the JSPM University Pune on the Board of Management of JSPM University Pune as prescribed in the JSPM University Act, under section 22 sub section (1) clause (b).

<u>**R-1.5/2023</u>**: The Board **RESOLVED** to **APPROVE** the nomination of nominate Dr. S. B. Nimse and Dr. Ajit R. Thete on the Board of Management of JSPM University Pune in accordance with the prescribed section 22 sub section (1) clause (b) of the JSPM University Act.</u>

#### <u>Item 1.6:</u> To make provisions for curricular, co-curricular, extracurricular activities for the students and employees.

Prof. B. B. Ahuja, Hon'ble Vice-Chancellor informed the Hon'ble Members of the Governing Body about the curricular, co-curricular, extracurricular activities scheduled for the students and employees for the Academic Year2023-2024.

<u>**R-1.6/2023</u>**: The Board **RESOLVED** to **APPROVE** the introduction of various Clubs at School level as provisioned for curricular, co-curricular, extracurricular activities, for the students and its employees and advised on detailed formulation of the same.</u>

#### <u>Item 1.7:</u> To consider creation of academic, technical, administrative, ministerial and other necessary posts.

Prof. B. B. Ahuja, Hon'ble Vice-Chancellor informed the Hon'ble Members of the Governing Body that as per as per the Institutional Development Plan spelt out by UGC, the Faculty to Student ratio mandated for various programmes in different disciplines of study vary in the range of 1:15 to 1.30 for UG programs and 1:10 to 1:15 for PG programs.

Prof. B.B. Ahuja requested the Hon'ble Members of the Governing Body to consider and sanction the teaching posts at each of the schools in the overall ratio of 1:15 for all UG and PG programmes (except where UGC mandates a FSR of 1:10 for PG programmes), such that at all instances we cater to a Faculty to Student ratio bettered to UGC norms.

He further proposed that in view of the digitalization adopted in most aspects of functioning of the University, the non-teaching posts including administrative, technical and supporting staff (ministerial staff and technical staff) be appointed in the ratio of 1:0.5. Moreover, since housekeeping, peons and security services will be outsourced this ration of 1:0.5 would be adequate. Further, it was proposed that, the housekeeping staff (dry & wet, inclusive of gardening), peons and security be appointed on the contractual basis.

<u>**R-1.7/2023</u>**: The Board **RESOLVED to APPROVE** a Faculty to Student ratio of 1:15 for all UG and PG programmes (except where UGC mandates a FSR of 1:10 for PG programmes). The Board further **RESOLVED** to **APPROVE** the non-teaching posts including administrative, technical and supporting staff (ministerial staff and technical staff) be appointed in the ratio of 1:0.5 and housekeeping staff (dry & wet, inclusive of gardening), peons and security be appointed on the contractual basis.</u>

Prof. B. B. <u>**R-1.8/2023</u>**: The Board **RESOLVED to APPROVE** the appointment of an internal fee committee to the University which will act as a pre-review fee committee to appraise the proposed fee structure, which will then be submitted to the State Government for its approval, as prescribed in the JSPM University Act.</u>

Item 1.9: To approve the budgets and progress/activity report of the University. Prof. B. B. Ahuja, Hon'ble Vice-Chancellor presented the Budget for the FY 2023-24. He informed that around 4260 new admissions are envisaged for AY 2023-24 under various schools in different disciplines of study. He further briefed that the budget is based on the proposed fee structure and the expected student strength presented during the governing body meeting.

He highlighted that In AY 2023-24 total income is budgeted at ₹ 80.00 crores and total expenses are budgeted at ₹ 80.00 crores.

After detailed discussion, the members of the Governing Body adopted the budget for the FY 2023-24, as presented and annexed at **APPENDIX-II**.

<u>**R-1.9/2023</u>**: The Board **RESOLVED to APPROVE the** Budget for FY 2023-24 as presented.</u>
