The committee will meet every quarter in a year and the quorum for each meeting will be 75% of the members.

**The Internal Quality Assurance Cell (IQAC) will be responsible for:**

1. Developing and implementing quality benchmarks for academic and administrative activities;
2. Facilitating the creation of a learner-centric environment that promotes innovation and academic excellence;
3. Collection and analysis of feedback from all stakeholders on quality-related institutional processes;
4. Initiating measures to enhance research and development activities;
5. Ensuring effective feedback mechanisms for continuous improvement;
6. Organizing workshops, seminars, and training programs on quality-related themes;

7. Documentation of the various programmes/activities leading to quality improvement;
8. Collaborating with external agencies for quality assessment and accreditation;
9. Development and maintenance of institutional database through MIS for the purpose of maintaining /enhancing the institutional quality;
10. Periodical conduct of Academic and Administrative Audit and its follow-up
11. Preparation and submission of the Annual Quality Assurance Report (AQAR) as per guidelines and parameters of NAAC.
